① Propósito ② Requisitos ③ Evaluación	① This subject aims at familiarizing students with the implications of adopting a functionalist approach (vs. formalist approach) to the study of language. If human communication is conceived as a mere process of codification and decodification, a partial and inexact view of it will be given. Instead, functionalist approaches take as their object of study the speaker's <i>communicative competence</i> . In order to achieve a better grasp of the communicative competence of speakers, attention must be paid to the area of linguistics known as pragmatics . Pragmatic theories are chiefly concerned with the mechanisms that human beings use and which take them from <i>what is said</i> literally to <i>what is meant</i> .
